Hopefully you are already aware of the Club's commitment to replacing the roof at the SWCC HQ. Details are described in the <u>prospectus</u> which was sent out in July and which is now available on the club's new web site.

The fund raising plan outlined in the prospectus identified long term planned saving and debentures as key ways of raising just over a third of the estimated £150k required.

After some delay we have now set up a separate, dedicated, SWCC Roof Fund bank account and Fred Levett has kindly agreed to administer donations. These will be anonymous to all except Fred, and will be returnable should the project not go ahead.

At this stage we are launching the 'Planned Saving' scheme and are asking current full members to commit to a donating £2 / week (or more if you wish) through a standing order. It is interesting to note that if all of our 300 members were to this we would raise an impressive £93,600 in 3 years.

For those who may wish to contribute in other ways we are still hoping to be able to offer a life membership option in return for a one off donation of £500. Unfortunately this will require a constitutional change which we will have to take to the 2017 AGM. Subject to it being approved we plan to make this available in Sept 2017.

We really do need to kick start this initiative and be able to demonstrate to potential grant funding bodies

that as a club we are both serious and committed to making this happen, so please don't be shy.
